

DATA PROTECTION POLICY

1. Purpose and scope of this policy

The purpose of this information notice is to set out the data protection and data management principles of the owner of the **aicityvideo.com** website, **innoGold Pro Üzleti Technológia Fejlesztő Kft.** (represented by **Péter Vonnák**), which it recognises as binding upon itself as a data controller.
